



## VEHICLE LOANER AGREEMENT

In consideration of the loan to me of the vehicle described below by THE PICKLER COMPANIES, I hereby aver and agree to the following:

- 1) The Pickler Companies is loaning me the following vehicle:
  - a. Make/Model: **2000 Ford E35** License Plate: **U55 99N**

- 2) I am at least 21 years of age, and I am licensed to operate a motor vehicle.

- 3) I agree that I assume sole and absolute responsibility and liability for any damage to the vehicle described above until such time as I have returned the vehicle to the care of a representative of The Pickler Companies. If the vehicle is involved in any accident, I will pay, indemnify and hold The Pickler Companies harmless from all expenses, claims, suits, demands, costs and attorney's fees relating to any such incident. This shall include all damages, loss, expenses, fees and/or claim resulting from or relating to the operation of the vehicle while it is in my care and control and resulting from or relating to the steps that The Pickler Companies must take to protect its rights under this agreement. Should The Pickler Companies' insurer be required to cover any damage, I will pay the deductible.
- 4) If the vehicle is involved in any accident, I will immediately furnish The Pickler Companies a full and complete written report thereof including but not limited to any traffic citations issued, any information available as to the identity of any other individuals involved in the incident, any insurance claim number assigned to the case by my insurer, and a description of the incident including any police report in my possession.
- 5) I aver that I have insurance that complies with the requirements of the state of Tennessee and I will submit a copy of my proof of insurance to The Pickler Companies prior to taking possession of the vehicle. - 6) I waive all liability of The Pickler Companies and The Pickler Companies' employees for damages or expenses incurred due to negligence relating to such vehicle except willful negligence.
- 7) The vehicle will remain in my care and control until I return it. Each driver of the vehicle must sign a separate Vehicle Loaner Agreement to be an authorized driver, and I will not allow any unauthorized driver to operate the vehicle.
- 8) I will return the vehicle in its present condition to a Pickler Companies representative at its place of business before close of business on \_\_\_\_\_
- 9) **THIS IS A NON-SMOKING VEHICLE.** I agree not to smoke in the vehicle or carry any pets. I will return without trash or stains to interior.
